1. Mike Davey spoke about the Friend's of LI Wrestling sponsored Russian Meet on November 19th at Hofstra.
2. Dean Morrison spoke about "Prodigal Sport" Pre Season Tournament on November 21st.
3. Motion to approve minutes from May Meeting, second by Tom Maddock, approved.
4. Doug Axman spoke about directory update information & coaches web site.

5. Introduction of New Coaches; Stephon Sair of Manhasset, Joe Pumo of Oceanside, Chris MacDonald of Glen Cove, Dan Disalvo of Great Neck No. Mentors will be made available to the coaches. John Mankowich , Athletic Director at Jericho will be helping out the association during the season.
6. Laura Maddock spoke about our finances. Outline of finances is attached. Laura indicated we are able to increase our scholarships to \$750. We will continue to provide clothing for the State Team and pay for coaches membership fees for Friends of LI Wrestling & Long Island Wrestling Assoc. Fees TBD
Ken Garcia will have the raffle tickets ready for the November meeting. Each team is allotted about 200 tickets. If a team takes a large amount of tickets which we have to print, it was suggested that a larger contribution to coaches assoc. be made. Each team is responsible for at least \$350 (Program Ads or Raffles). \$350 qualifies your wrestlers for scholarships and awards at end of season.
Lara announced the wrestlers who sent in thank you letters for their scholarships.
7. Neil Duncan spoke about his company T W Promotions. The company deals with Resilite & Asics. Neil spoke of their new light weight mat. They will also be putting out a new web site.
8. Ed stated that he will be sending out information from the State regarding skin infections. This is to help educate wrestlers, parents and coaches.
9. Ed stated that the Section 8 Coaches Directory Book has incorrect information regarding points and tournaments. We are allowed 20 points and six (6) tournaments.
10. 96 and 285 are mandatory weight classes in dual meets and tournaments.
11. Ed will be working with Cliff Forziat on the Coaches Guide Book.
12. Steve Kocienda will not be coaching at Glen Cove. Steve was to take over as President. Doug Axman made a motion to extend Mike Leonard's Presidency for one (1) more year. 13. Dual Meet Playoffs : County Dual Meet Tournament - Top three (3) from each League qualifies. Top 8 champions are seeded, others fall automatically.
A Qualifying & Dual Meet Tournament committee will be formed to rank the teams in the Qualifiers and Top 8 in playoffs. One (1) rep from each League & an alternate.
The eight reps rank all teams for qualifiers & top 8 . However, if a League rep is a top 8, the alternate fills in to rank the top 8.
